**Eligibility Guidelines-** Applicants must fall within the income limits as listed below. Applicants eligible for the project based subsidized (PBV) and the HUD subsidized units must have income at or below 30% of the median income, as listed below. To qualify for a one bedroom HUD subsidized project based unit an individual must be disabled. Applicants eligible for the MRVP subsidized units must have income at or below 50% of the median income. Applicants eligible for LIHTC units must verify rent affordability, these are rent restricted units and therefore there are no subsidies with these units. There is a fulltime student restriction.

**Income Limits** (maximum annual income allowable, effective (4/1/18).

**For project based subsidized and HUD subsidized units:**

One person \$16,950 Two person \$19,400 Three person \$21,800 Four person \$25,100

**For MRVP subsidized units:** Two person \$32,300 Three person \$36,350 Four person \$40,350

**For LIHTC units ONLY:** One person \$33,900 Two Person \$38,760  
Three person \$43,620 Four person \$48,420

**Rents** - Rents for project based subsidized units and HUD units are based on 30% of the monthly income of the household. Rents for MRVP units are based on 35% to 40% of the monthly income of the household. For all subsidized units allowances are made for medical expenses, utilities, and child care.

Rents for LIHTC One bedroom \$632 Two bedroom \$755 Three bedroom \$887. Rents for LIHTC units are set in accordance with the Low Income Housing Tax credits maximum allowable rents.

Tenants pay ALL utilities. Appliances include stove and refrigerator.

**Building and Apartment Features** – Brattlebrook Village apartments are located off of Dalton Division Rd. on April Lane in Pittsfield. There is an onsite maintenance service and community room. There is coin operated laundry room and a play area with playground equipment for children.

**Pets** - **Pets are allowed in accordance with our Pet Policy.**

**This is a non-smoking property.**

**Waiting List Selection** - Waiting list selection will be done on a first come first serve basis in accordance with date and time of application. Apartments are rented without regard to race, color, religion, sex national origin, handicap or familial status. Federal law prohibits the discrimination against individuals with handicaps.
